Today, at a time when society recognizes the importance of good economic management more than ever, we are here to build solutions: ISEG - 113 years of a School of Firsts Semi-final of the international Hult Prize competition worth a million dollars returns to Portugal and ISEG

For the second year running, ISEG - Lisbon School of Economics & Management will host the semi-finals of the prestigious international Hult Prize competition. This event, which will take place on the 21st, 22nd, and 23rd June 2024, offers university students the chance to turn innovative ideas into sustainable businesses with a positive social impact, competing for a prize of one million dollars.

The Hult Prize is the largest social entrepreneurship competition on a global scale, challenging thousands of university students every year to develop innovative start-ups with the potential to transform the world. With four exciting phases and a final prize of one million dollars, the competition aims to inspire the next generation of leaders and social entrepreneurs.

This year, ISEG will have the privilege of hosting 56 startups, involving 176 university students from 48 different nationalities. These teams will be in close competition for one of the six places in the final of the Hult Prize, which is scheduled to take place in September in London, UK.



The Hult Prize celebrates its 15th anniversary this year, leaving a positive impact on more than one million university students in more than 100 countries around the globe. Its main mission is to address the major global challenges through social entrepreneurship and a positive global impact, always in line with the UN's Sustainable Development Goals (SDGs). This year, the theme of the annual challenge is 'Unlimited', whereby business ideas can contribute to any of the SDGs.

The first phase of the competition takes place locally, at the more than 1,000 universities that promote the Hult Prize OnCampus Programme each year. Organised by student volunteers and led by a Campus Director, the OnCampus programme made its debut in Portugal this year and already has the support of 28 higher education institutions in the country. This programme is therefore in an expansion phase, with the objective to become an important initiative in the Portuguese market, just as it is on the international stage.

Together with those teams selected through the Open App, the winners of each OnCampus programme then go on to compete internationally in one of the seven semi-finals (Global Summits) that are held in various countries, including Portugal. Out of the more than 30 Portuguese teams that took part in the different national OnCampus programmes, two have currently gone through to the semi-final stage.

After the semi-finals, around 20 teams will be selected to take part in the Hult Prize Accelerator, where they will receive daily support from experts to 'accelerate' the process of transforming ideas into investmentready business models. Finally, six of these teams will then compete in the final in London, where one of them will be the big winner.


